

## **Fly Away With Epson - Terms and Conditions**

1. Purchase a new **qualifying Epson printer** from **1<sup>st</sup> November 2011 to 15<sup>th</sup> January 2012**, and you can claim the Air Fare Cost for a return flight in economy class to any of the listed destinations in the table below. If you also purchase a genuine Epson ink multipack, containing 3 or more ink cartridges, at the same time of purchasing a qualifying printer, you can claim the Air Fare cost for an extra return flight. This promotion is available for purchases made in one of the Participating Countries and a maximum of two (2) flights can be claimed per household and booking.

2. An "Air Fare Cost" is the cost of the airline's base fare which Epson will pay for a participant via redemption of this promotion. All other costs associated with the flight will be borne by the participant and are excluded from the Air Fare Cost. Such other costs include, but are not limited to (i) any baggage or other charges made in connection with the flight or in addition to the base fare (ii) any taxes, passenger duty, fuel surcharges, service charge and airport fees (iii) any insurance (iv) any additional fees for card payments (v) any fees for seat upgrade, food and drink (vi) any fees for hotel, car hire, airport transfers, taxis, car park or any other additional services. You are not entitled to demand a particular airline or route.

5. To claim please go to [www.epson.co.uk/flights](http://www.epson.co.uk/flights). Complete and submit the claim form online, then print out the completed booking form and post together with a cut out of the barcode on the printer packaging, a copy of the receipt showing the purchase date, product description and store name, to travel agents ("Inspire") at the address stated on the booking form at least 30 days before the planned trip but no later than 10th April 2012. If you are claiming an extra flight for the purchase of a multipack at the same time as the printer, you must also post the top/lid of the multipack that visibly shows the barcode.

6. No bookings will be made by Inspire for participants who fail to provide the proofs of purchase specified above.

7. The offer of an Air Fare Cost for a return flight is subject to flight availability. This offer does not entitle the participant to travel by a particular route on a particular date. This offer is not valid for journeys over Christmas Day and New Years Day. Some periods (e.g. holiday periods) and dates may be restricted depending on the chosen destination and travel time. The availability of flights may also be restricted by special events, trade fairs or local holidays.

8. For this reason Inspire will require participants to supply their top 3 destinations and 3 dates. Once the participant is offered a specific flight by Inspire he/she must notify Inspire as

soon as possible, as to whether he/she wishes to accept the offer. Price and availability of flight offered are not guaranteed until the offer is accepted and all additional costs are paid.

9. At the point of offering a participant a flight, Inspire will inform the participant of the Air fare Cost and the additional costs or charges which the participant will be required to pay. Participants must make full payment of additional costs to Inspire before flights can be booked. Flights must be booked and paid for by 30<sup>th</sup> April 2012. If the participant and/or any person travelling with the participant does not satisfy this request within the required time, the participant shall lose his/her entitlement to the Air fare Cost.

10. Subject to receiving full payment of additional costs from participant, Inspire will make flight booking and send an email confirmation of flight to participant

11. No cancellations or changes will be accepted once the booking has been confirmed.

12. The flight ticket is not transferable. Flights may not be booked by third parties using the name of the participant

13. All bookings for the flights must be made by 30<sup>th</sup> April 2012.

14. All travel (departure and return) must be completed by 31<sup>st</sup> March 2013.

15. The maximum period between the outward and return flights is 30 days.

16. Each Air Fare Cost claim is limited to a single use. No cash will be offered in exchange for the Air Fare Cost.

17. The contract for the flight will be made between the participant and the airline on the terms specified by the airline in the same way as if the participant were purchasing a ticket from the airline in the usual way. Epson does not guarantee the airlines performance or its contractual obligation to you the passenger

18. Epson does not accept liability for changes to flight schedules, routes or destinations and reserves the right to use other service providers as an alternative. On some routes it is necessary to stop over on Saturday night. All instructions on the booking form must be observed by the participant.

19. The right of the participant and any person travelling with the participant to claim compensation is subject to legal and airline regulatory provisions.

20. Subject to the law you will not be entitled to claim the Air Fare Cost if you return the product(s).

21. Epson will not accept any responsibility for claims lost and delayed or for those claims not received by the closing date. It is your responsibility to ensure that correct details are provided for claims to be processed.
